This program is available on the Manitoba Agriculture, Food and Rural Initiatives web page and is called Farmplan-Financial and Production Software.

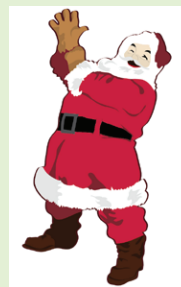

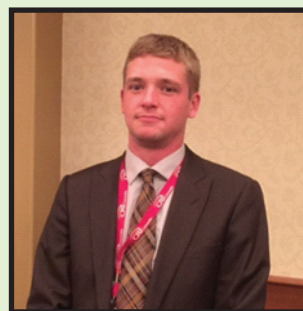
